

A GUIDE TO: CASH DEPOSITS

Overview

The following guidelines are applicable where the client intends to make a deposit to their portfolio which is not part of a transfer in from another service provider.

If at any time a client wishes to transfer funds into their portfolio, they can do so either via cheque or electronic transfer.

Cheque Deposits:

Cheques should be made payable to **Pershing Securities Limited** and not to King & Shaxson to avoid delays in having the funds credited to the portfolio.

All transfers of funds via cheque should be sent to the following address, along with a covering letter, quoting the unique portfolio number to where the funds are to be credited:

We request that cheques are sent via our offices as:

- 1. Deposits to ISA's and GIA accounts are processed by different teams at Pershing
- 2. It allows King & Shaxson to monitor the crediting of the clients portfolio.
- 3. It allows King & Shaxson to acknowledge receipt and subsequent crediting of the funds to the client

Electronic Deposits:

Monies can be deposited directly to Pershing Securities Limited for crediting to the clients portfolio via electronic means (bank transfer).

Full details of where to make deposits in GBP, EUR and USD are overleaf.

Points to Note

- For new clients no attempt to deposit by electronic means should be made until they
 have received confirmation that their account is open and have been given a portfolio
 reference. If a portfolio has not been confirmed as open, monies will be returned to the
 remitting bank.
- 2. It is essential that any deposit made is referenced with the client's portfolio number to where the funds are to be credited. Failure to do so will delay the crediting of funds to the nominated portfolio or may result in the funds being returned as unallocated to the remitting bank.
- 3. All deposits of money are subject to the usual anti-money laundering checks and clients are reminded that deposits should always be made from an account in the same name as which the portfolio is held and not from a third party.
- 4. It is recommended that the client informs King & Shaxson that a deposit has been made, so that they can monitor and confirm receipt. This can be done via e-mail to ethical.support@kasl.co.uk and suggested wording of said advice is given on appendix 1.
